COMPOSITION

Flex-C-Ment Bubble Gum Liquid Release is a bubble gum scented, clear, low viscosity, slow drying blend of evaporating, residue free release agents, that is a liquid bond breaker for the use in the imprinting process to allow the release of mat-type texturing tools from concrete or overlay surfaces.

USES

Flex-C-Ment's Bubble Gum Liquid Release Agent is used to lubribate concrete texturing tools, embossing skins, or rollers to provide an essay of the tool from the concrete surface. Flex-C-Ment's Bubble Gum Release Agent utilizes specialty additives to provide an enhanced positive release of all types of imprinting tools. Flex-C-Ment's Bubble Gum Liquid Release Agent is a release choice for applications where powdered products would be prohibitive, due to risk of damage to surrounding landscape, buildings, and interior finished surfaces.

CAUTIONS

Flex-C-Ment Bubble Gum Liquid Release Agent is combustile and should not be used near any potential ignition sources, including but not limited to open flames, plot lights, sparks and static electricity. All tools must be throughly cleaned of all residue or other liquid liquid releases and be allowed to dry completely prior to use. Flex-C-Ment Liquid Release should not be toweled into the surface or used for curing. Flex-C-Ment Bubble Gum Liquid Release Agent must be used within Flex-C-Ment standards and procedures for the Flex-C-Ment products to provide the maximum physical properties and prevent loss of bond to the substrate.

CLEANABILITY

In general, the more aggresive the finished surface, the greater the coefficient of friction and corresponding skid resistance, the more difficult to clean. The smoother the finished texture, the easier the surface is to clean, but there is loss of skid resistant properties. Cleaning and disinfecting compounds and cleaning techniques can affect the color, gloss, texture and performances of the system. As a precautionary step, Flex-C-Ment recommends that the end-user test their cleaning disinfecting compunds on a non-conspicuous area before use. Follow sealer manufacturer recommendations for mantenance and cleaning. Slip resistance is greatly affected by the sealers and texture used. Follow sealer manufacturer recommendations for slip resistance and prevention.

COVERAGE

Flex-C-Ments's Bubble Gum Liquid Release Agent actual coverage may vary depending on the application method, wind conditions, texture of concrete prior to application, and other local conditions. Under normal conditions will cover approximately 200 square feet per gallon.

SHELF LIFE

If properly stored, the expected shelf life can exceed 6 months. However, it is recommended that Flex-C-Ment Bubble Gum Liquid Release be used as soon as possible after delivery. Rotate stock to use oldest inventory first. Store under roof and keep dry.
